**Discounts where adults living at the property are disregarded**

If certain adults are 'disregarded' for Council Tax purposes, it may mean that they are entitled to a discount.

Disregarded adults fall into one of the following groups. **Proof we need:**

| Person in prison (or any other place of detention) | – We will send you a separate form.   |
| Severely mentally disabled                         | – Doctor's certificate and confirmation of appropriate allowances.                      |
| Where Child Benefit is being paid                  | – A copy of the first page of the payment book.   |
| Student  | – An up-to-date certificate from the college or university.                             |
| Apprentice   | – A copy of the agreement between the apprentice and the employer.                      |
| Youth Training Scheme                              | – A copy of the letter confirming your entry to the scheme.                             |
| Hospital patient                                   | – A letter from the hospital.   |
| Patient in a care home                             | – A letter from the care home, relative or doctor.                                      |
| Person who provides care                           | – A letter from the doctor. You can get a separate application form for this situation. |
| Person living in a hostel                          | – A letter from the hostel.   |
| School leaver                                      | – None as long as you were previously entitled to a student discount.                   |
| Member of a religious community                    | – A letter from the religious community.  |
| Diplomat   | – A copy of the diplomatic passport.  |

You can claim a discount if you or the other adults living in your home fall into one or more of the above groups, but there must not be more than one person living in your home (including you) who is not disregarded.
