General Information and Terms and Conditions for the Management and Maintenance of Graves within Cemeteries

Deed of Grant

Once your application has been considered, a Deed of the Grant of Exclusive Right of Burial will be sent to you. The Deed is for a period of fifty years.

(Details of how long it can be extended by, and time limit is currently not allowed, but is under consideration).

General

In being granted the Exclusive Right of Burial, we hereby agree to abide by the Burial Ground Regulations and are aware that no form of memorial, other than that prescribed under the Council's Burial Ground Regulations will be allowed to be placed on the purchased grave. We also acknowledge that any unauthorised item(s) will be removed from the grave space.

For your guidance the following restrictions apply:

All memorial stones must have a minimum thickness of 3" (0.08m).

Please refer to the Burial Ground Regulations regarding the workmanship of memorial masons and the maintenance of plots.

Provision of Memorials

Traditional Graves

Traditional graves may have a headstone and a kerb and set memorial surrounding the grave. The responsibility for maintenance of the memorial and interior is that of the grave owner(s)

Lawn Graves

If you purchase a Lawn grave there is provision for a headstone either at the head of the grave or on a concrete rafter (depending on type) only. You will not be allowed to plant out shrubs, trees, nor will you be allowed to place a surround to the grave or infill it. These areas are kept as a lawn and will be mowed and maintained by the Council. The graves will be periodically topped up and seeded after approximately 6 months following interment

Maintenance

The Council aims to provide a dignified setting, free from any fencing or vases, jars or planting around the memorial stones. The area will be maintained as lawns by the Cemetery staff who have been instructed to remove any unauthorised stones, plants, fences or any other borders so that we can keep the area well maintained for the benefit of all visitors to the Cemetery.

A permit must be obtained from the Council prior to a memorial being fixed, and as mentioned above, a fee will be payable.
