

Licensing Act 2003 - Applications completed in 2021

Please find below a list of Licensing Act 2003 applications completed since 1 January 2021 by the Licensing Authority, Worthing Borough Council, for new Premises Licences, Variations to existing Premises Licences and Review applications.

The terms of the Licensing Act 2003 dictate that all 'new' application and 'variation' applications are publicised and consulted on. If no representations are received from 'Responsible Authorities' or any other persons such applications must be granted as applied for. If relevant representations are received and mediation between the parties is unsuccessful then the application has to be deliberated by a sub-committee of the Licensing & Control Committee B following a hearing.

'Minor variations' are also consulted on but only by 'public notice' on the premises, details posted on this website and any responsible authorities the licensing authority selects as relevant. If relevant representations are received and considered by officers to have implications under the licensing objectives then the application is simply rejected and a full variation has to be applied for.

'Review' applications cannot be withdrawn unless a licence is surrendered and must be heard by the full Licensing Committee B whatever agreement mediation may produce.

Morrisons Daily

An application for a 'minor variation' to the premises licence at the 'McColls' store. The convenience store is situated at 66 Broadwater Road, Worthing, BN14 8AG

The licence authorises the sale of alcohol for consumption off the premises.

The application sought to vary the existing Licence to authorise:

- Alterations to the internal layout of the premises as part of a refurbishment.
- Change of the premises name from 'McColls' to 'Morrisons Daily'

No other changes were proposed by the application.

Licence holder and applicant: Martin McColl Ltd.

Committee Hearing: Not required for a minor variation

For a minor variation application, in addition to the statutory public consultation, the Licensing Authority has the discretion to consult any responsible authorities it considers necessary and relevant to the type of application. In this case, as it involved changes to the layout of the premises that could potentially have implications affecting the licensing objectives, Sussex Police, WSCC Fire & Rescue Service and the A&W Environmental Health Team were consulted.

No formal representations were received from members of the public or authorities consulted. After due consideration officers decided the changes proposed unlikely to have an adverse effect on the licensing objectives. Consequently, the minor variation was granted as per the terms of the Licensing Act 2003.

The Last Melon

An application for a 'minor variation' to the premises licence at the 'Last Melon'. The restaurant & bar is situated at 6 New Street, Worthing, BN11 3BT. The licence authorises the sale of alcohol for consumption on & off the premises and the provision of regulated entertainments.

The application sought to vary the existing Licence to authorise:

An extension for a further 3 months of the current temporary suspension of the conditions of Licence that requires food to be served with alcohol that have been in place since 17 June 2021. The effected conditions being:

- The premises will operate as a heavily food led premise with food always available to order at all times the premises is open...
- Alcohol supplied for consumption on the premises may only be consumed ancillary to a substantial meal
- Customers on the first floor will only be served with alcohol if they have eaten or are eating food ordered from the menu and are seated at the tables and chairs provided on that floor.

The applicant has offered to continue with a number of temporary conditions to address the licensing objectives.

Licence holder and applicant: Pink Café Ltd.

Consultation closed: Tuesday 14 December 2021

Committee Hearing: Not required for a Minor Variation

For a minor variation application, in addition to the statutory public consultation, the Licensing Authority has the discretion to consult any responsible authorities it considers necessary and relevant to the type of application. In this case, as it involved temporary changes to the conditions of licence that could potentially have implications affecting the licensing objectives, Sussex Police, WSCC Fire & Rescue Service and the A&W Environmental Health Team were consulted.

No formal representations were received from members of the public or authorities consulted. After due consideration officers decided the temporary changes proposed unlikely to have an adverse effect on the licensing objectives. Consequently, the minor variation was granted as per the terms of the Licensing Act 2003.

Thomas Food & Wine

An application for a new premises licence to allow the sale of alcohol as part of a Convenience Store to be known as 'Thomas Food & Wine'. The shop to be situated at 113 Rectory Road, Worthing, BN14 7PH.

The shop was previously licensed but closed as a result of extensive fire damage in 2018.

The store is reopening and the application sought authorisation for the sale of alcohol for consumption off the premises.

No relevant representations were received from members of the public but the application attracted a representation from a responsible authority - Sussex Police.

The Licensing Act encourages mediation and this was conducted successfully. The Authority's concerns were addressed by the applicant volunteering a number of conditions to the premises' operating schedule that will become enforceable conditions of licence. As a result of these conditions the representation was withdrawn.

Consequently, an amended licence was granted as per the terms of the Licensing Act 2003.

Continental Café

An application for a full variation to the premises licence at the 'Continental Cafe'. The cafe is situated at 17 Warwick Street, Worthing, BN11 3DF

The current licence authorises the sale of alcohol for consumption on & off the premises 10:00hrs to 23:00hrs Mon – Sat. & 12:00hrs to 22:30hrs Sun.

The application sought to vary the existing Licence to:

- Extend the hours for Alcohol Sales to:
 - 10:00hrs to 01:00hrs (of the following morning) Monday – Saturday
 - 11:00hrs to 22:30hrs Sunday.
- Authorise the Provision of Recorded Music:
 - 10:00hrs to 01:00hrs (of the following morning) Monday – Saturday
 - 11:00hrs to 22:30hrs Sunday.
- Authorise the Provision of Live Music:
 - 12:00hrs to 01:00hrs (of the following morning) Friday & Saturday
- Opening to the Public:
 - 09:00hrs to 01:00hrs (of the following morning) Monday - Thursday
 - 09:00hrs to 02:00hrs (of the following morning) Friday & Saturday
 - 09:00hrs to 00:00hrs (midnight) Sunday
- Remove the following conditions from the licence:
 - Intoxicating liquor may be served only to a person who is either partaking of a table meal or light refreshment or to a person who is accompanied by someone partaking of a table meal or light refreshment.
 - The total number of customers at any time in the premises shall be restricted to 50 persons.
 - The Embedded Restrictions from the old Justices' Licence regarding Children

All other conditions of licence to remain unchanged.

Committee Hearing: Cancelled - not required.

No relevant representations were received from the public but the application attracted two representations from responsible authorities. These being Sussex Police and the A&W Environmental Protection Team.

The Licensing Act encourages mediation and this was conducted successfully. The Authorities' concerns were addressed by the applicant amending the timings for some of the licensable activity sought and volunteering a number of conditions to the premises' operating schedule that will become enforceable conditions of licence. As a result of these amendments and enforceable conditions the representations were withdrawn.

Consequently, an amended licence was granted as per the terms of the Licensing Act 2003.

Snow Pebble Alpine Bar & Grill

An application for a new temporary premises licence to allow licensable activity between 1 December 2021 and 16 January 2022 as part of a pop-up bar & restaurant to be known as the 'Snow Pebble Alpine Bar & Grill'. The temporary pop-up venue to be situated at The Montague Place Event Space, Montague Place, Worthing, BN11 3BG.

The application sought authorisation for the sale of alcohol, for consumption on the premises, and the provision of recorded music.

The Licensing Act encourages mediation and this was conducted successfully. The member of the public and the Authorities' concerns were addressed by the applicant volunteering a number of conditions to the premises' operating schedule that will become enforceable conditions of licence. As a result of these conditions the representations were withdrawn.

Consequently, an amended licence was granted as per the terms of the Licensing Act 2003.

Pavilion Bowls Club

An application for a new premises licence to allow the sale of alcohol & provision of regulated entertainment at the 'Pavilion Bowls Club'. The club is situated at 78 Pavilion Road, Worthing, BN14 7EQ.

The application sought authorisation for the sale of alcohol for consumption on the premises.

No relevant representations were received from members of the public but the application attracted a representation from a responsible authority - Sussex Police.

The Licensing Act encourages mediation and this was conducted successfully. The Authority's concerns were addressed by the applicant volunteering a number of conditions to the premises' operating schedule that will become enforceable conditions of licence. As a result of these conditions the representation was withdrawn.

Consequently, an amended licence was granted as per the terms of the Licensing Act 2003.

Jungle Nightclub

An application for a 'minor variation' to the premises licence at the 'Jungle Nightclub'. The venue 31 Chatsworth Road, Worthing, BN11 1LY. The licence authorises the sale of alcohol for consumption on the premises and the provision of regulated entertainment & late night refreshment.

The application sought to vary the existing Licence to authorise:

- Relocation of the venue's outdoor smoking area from the west side of the building, adjacent to the main entrance, to the area adjacent to venues rear exit on the eastern side away from the entrance queue.

No changes were proposed to the hours for licensable activities currently permitted.

Committee Hearing: Not required for a minor variation

For a minor variation application, in addition to the statutory public consultation, the Licensing Authority has the discretion to consult any responsible authorities it considers necessary and relevant to the type of application. In this case, as it involved changes to the layout of the premises that could potentially have implications affecting the licensing objectives, Sussex Police, WSCC Fire & Rescue Service and the A&W Environmental Health Team were consulted.

Sussex Police and the A&W Environmental Protection Team discussed with the applicant the proposal and the applicant accordingly volunteered a number of enforceable conditions governing the use of the smoking area.

No formal representations were received from members of the public or authorities consulted. After due consideration officers decided the changes proposed together with the conditions volunteered meant the change of layout unlikely to have an adverse effect on the licensing objectives. Consequently, the minor variation was granted as per the terms of the Licensing Act 2003.

Karma Lounge

An application for a new premises licence to allow the sale of alcohol as part of a new proposed bakery & pizzeria with pavement forecourt to be known as the 'Karma Lounge'. The venue to be situated at 171-173 Tarring Road, Worthing, BN11 4HH.

The application sought authorisation for the sale of alcohol for consumption on & off the premises.

- Opening to the Public:
 - 09.00hrs to 23:00hrs Monday – Sunday incl.

The applicant offered a number of conditions in the operating schedule to address the licensing objectives.

Consultation closed: Wednesday 22 September 2021

Committee Hearing: Held on Monday 18 October 2021

A number of representations have been received from the public and responsible authorities. The Licensing Act 2003 encourages mediation but this was only partially successful. Accordingly the application was referred to a Licensing & Control Sub-Committee to consider.

The Sub-Committee considered all the written & oral representations and heard statements from the applicant's representative and members of the public. It resolved that the premises licence should be granted with all of the additional conditions agreed with Sussex Police and volunteered at the hearing to address the concerns of the A&W Environment Protection Team.

The grant of the premises licence is subject to the following:

- Sale of Alcohol for consumption on & off the premises amended to:
- 11:00hrs to 22:40hrs Mon – Sun incl.
- All the relevant conditions volunteered by the applicant in the operating schedule and during mediation.
- The mandatory conditions required by the Licensing Act 2003 and all other relevant legislation.

The Sub-Committee considered:

- The representations made by the Responsible Authorities.
- The mediation during which the applicant had offered to amend the timings applied for and agreed to include the further licence conditions suggested by Sussex Police & the A&W Environment Protection Team being placed on the licence and
- The relevant representations from the Public which had not been withdrawn.
- Human rights legislation and the rules of natural justice.

In discharging its functions the Committee did so with a view to promoting the Licensing objectives particularly regarding the prevention of crime & disorder and the prevention of public nuisance.

The Committee listened carefully and considered all written and oral representations that were made. It was satisfied that with all of the additional conditions placed on the licence that the licensing objectives would not be undermined.

Moes @ Limited

An application for a new premises licence to allow the sale of alcohol as part of a new proposed coffee bar & cafe to be known as the 'Moes @ Limited'. The venue is to be situated at 14-16 Portland Road, Worthing, BN11 1QN.

The application sought authorisation for the sale of alcohol for consumption on & off the premises.

The Authorities' concerns were addressed by the applicant volunteering a number of conditions to the premises' operating schedule that will become enforceable conditions of licence. The application sought to vary the existing Licence to extend the hours for licensable activity to:

 - 10:00hrs to 01:30hrs (of the following morning) Monday – Sunday incl.
- Late Night Refreshment:
 - 23:00hrs to 01:30hrs (of the following morning) Monday – Sunday incl.
- Opening to the Public:
 - 10:00hrs to 02:00hrs (of the following morning) Monday – Sunday incl.
- Amend the condition of licence that temporarily allowed the premises to place tables & chairs in a designated area of the pavement into a permanent permission and extend the closing time of the area from 22:30hrs to 23:00hrs.
- Amend a condition of licence that restricted new entry to 00:00hrs to 01:00hrs
- Authorise the Provision of regulated entertainment in the form of recorded music:
 - 12:00hrs to 01:30hrs (of the following morning) Sunday - Thursday
 - 12:00hrs to 01:40hrs (of the following morning) Friday & Saturday
 - 12:00hrs to 02:00hrs (of the following morning) Christmas Eve & New Year's Eve
- No further changes were proposed.

Licence holder and applicant: Manuka Bar & Kitchen Ltd.

Consultation closed: Friday 20 August 2021

Committee Hearing: Held on Wednesday 15 September 2021.

The Sub-Committee considered all the written & oral representations and heard statements from the applicant and members of the public. It resolved that the variation to the premises licence should be granted with all of the additional conditions agreed with Environment Protection Team and the additional conditions agreed with some of the persons who made the representations.

The grant of the variation is subject to the amended hours agreed by the applicant:

 - 12:00hrs to 01:00hrs (of the following morning) Mon – Sun incl.

- Authorise the last entry to the premises at 00:30hrs Mon - Sun incl.
- Authorise the premises to place tables & chairs in a designated area of the pavement
 - 18:00hrs - 22:30hrs Sunday - Friday
 - 16:00hrs - 22:30hrs Saturday

All the relevant conditions volunteered by the applicant in the operating schedule and the mandatory conditions required by the Licensing Act 2003 and all other relevant legislation.

The Sub-Committee considered:

- The representations made by the Responsible Authority.
- The mediation during which the applicant had offered to amend the timings applied for and agreed to include the further licence conditions suggested by Sussex Police being placed on the licence and
- The remaining relevant representations from the Public which had not been withdrawn.
- Human rights legislation and the rules of natural justice.

In discharging its functions the Committee did so with a view to promoting the Licensing objectives.

The Committee listened carefully and considered all written and oral representations that were made. It was satisfied that with all of the additional conditions that the licencing objectives would not be undermined. The Committee welcomed the applicants offer to reduce the hours in relation to the outside tables.

The venue has in place an existing premises licence which will be surrendered if this application is granted.

The applicant offered a number of conditions in the operating schedule to address the licensing objectives.

Licence holder and applicant: Brewhouse & Kitchen Ltd.

Consultation closed: Tuesday 29 December 2020

Committee Hearing: Held on Wednesday 27 January 2021 online via Zoom.

Consultation on this application resulted in six representations being received from members of the public and the application attracted two representations from the responsible authorities. In this case Sussex Police and the A&W Councils' Environmental Protection Team.

The Licensing Act encourages mediation and this was conducted successfully with the Responsible Authorities. Their concerns were addressed by the applicant volunteering a number of conditions to the premises' operating schedule that will become enforceable conditions of any varied licence granted in addition to those detailed in the application and also amended the hours sought for licensable activity to 07:00hrs to 00:00hrs (midnight) Monday – Sunday

Mediation with the local residents was only partially successful so the application was referred to a Licensing & Control Sub-Committee to consider at hearing.

The Sub-Committee considered all the written representations and heard from the applicant and resolved that the Variation to the Premises Licence be granted as applied for but imposed all the conditions and amended timings agreed with the Responsible Authorities prior to the hearing.

The grant of the licence was also subject to all the relevant conditions volunteered by the applicant in the operating schedule and the mandatory conditions required by the Licensing Act 2003 and all other relevant legislation.

The Sub-Committee considered all the representations made but considered that the conditions recommended by Sussex Police and the Environmental Protection Team adequately addressed issues relating to this application and the conditions imposed would adequately promote the licensing objectives.

Yummy Pizza

An application for a new premises licence to allow the sale of late night refreshment as part of a hot food takeaway with delivery service known as Yummy Pizza. The takeaway restaurant is situated at 191 Tarring Road, Worthing, BN11 4HN.

No relevant representations were received from members of the public but the application attracted two representations from responsible authorities. In this case Sussex Police and A&W Councils' Environmental Protection Team.

The Licensing Act encourages mediation and this was conducted successfully. The Authorities' concerns were addressed by the applicant volunteering a number of conditions to the premises' operating schedule that will become enforceable conditions of licence. As a result of these conditions the representations were withdrawn.

Consequently, an amended licence was granted as per the terms of the Licensing Act 2003.

Hand Brewing Co. Ltd.

An application for a new premises licence to allow alcohol sales for consumption on & off the premises at a new brewery & tap room to be known as the 'Hand Brewing Co'. The brewery & tap room to be situated at Unit 6a, Garcia Trading Estate, Canterbury Road, Worthing, BN13 1AL

The application sought authorisation for the sale of alcohol for consumption on & off the premises.

- Opening to the Public:
 - 11:00hrs to 21:00hrs Monday - Sunday

The applicant offered a number of conditions in the operating schedule to address the licensing objectives.

Licence holder and applicant: The Hand Brewing Co. Ltd.

Consultation closed: Sunday 17 January 2021

Committee Hearing: Not required

No relevant representations were received from members of the public but the application attracted a representation from a responsible authority. In this case Sussex Police.

The Licensing Act encourages mediation and this was conducted successfully. The Authority's concerns were addressed by the applicant volunteering a number of conditions to the premises' operating schedule that will become enforceable conditions of licence. As a result of these conditions the representation was withdrawn.

Consequently, an amended licence was granted as per the terms of the Licensing Act 2003.

PizzaFace

An application for a 'minor variation' to the premises licence at 'PizzaFace'. The cafe-restaurant is situated at 138-140 Montague Street, Worthing, BN11 3HG. The licence authorises the sale of alcohol for consumption on & off the premises and the provision of regulated entertainment:

- Sale of Alcohol:
 - 11:00hrs to 23:00hrs Monday - Sunday

The application sought to vary the existing Licence to:

- Remove a condition of the premises licence that states:
 - Alcohol shall not be sold or supplied, either as takeaway or delivered, other than to persons ordering substantial meals

To allow the sale of alcohol for take away, delivery or for consumption in the restaurant without the need for a food sale.

No other changes to the licence were sought.

After consulting with Sussex Police the applicant offered a number of new conditions to modernise the licence and address the licensing objectives.

Committee Hearing: Not required for a minor variation

For a minor variation application, in addition to the statutory public consultation, the Licensing Authority has the discretion to consult any responsible authorities it considers necessary and relevant to the type of application. In this case, as it involves changes to the conditions of licence that could potentially have implications affecting the licensing objectives, Sussex Police and the A&W Environmental Health Team were consulted.

No formal representations were received from members of the public or authorities consulted. After due consideration officers decided the changes proposed unlikely to have an adverse effect on the licensing objectives. Consequently, the minor variation was granted as per the terms of the Licensing Act 2003.
